Annual Business Meeting Agenda International Association for Great Lakes Research Virtual meeting

May 19, 2021, 12:00 – 13:15, Eastern Time

- 1. Call to order
 - President Ed Verhamme called the meeting to order at 12:05pm. He thanked everyone for joining the meeting, and asked participants to check out the sponsors and exhibitors. He thanked the conference organizers and noted that they likely had to devote much more effort than they had anticipated to this virtual meeting. He reminded the members that we are a 501©3 organization and the annual business meeting is a legal requirement.
- 2. Approval of meeting agenda

- 3. Approval of 2020 minutes

- 4. President's report (Ed Verhamme)
 - President Verhamme reminded members that IAGLR will be involved in four conferences in 2022: the State of Lake Erie (Cleveland), the annual conference which will be held as part of the Joint Aquatic Science Meeting (Grand Rapids), the State of Lake Michigan (Traverse City), and the ELLS-IAGLR meeting (Petrozavodsk, Russia).
- 5. Treasurer's report (prepared by Scott McNaught and presented by Ed Verhamme)
 - The Association saw a notable decline in revenue in 2020, but also a decline in expenses. This was an odd year with the pandemic, but we still have healthy numbers in the investment accounts. We were able to weather the pandemic because of good financial decisions made by past boards.
- 6. Publication Report (prepared by Jim Bence and presented by Ed Verhamme)
 - The Journal is doing well, with 123 submissions by the end of April. Downloads continue to increase. Revenues fully support editorial office operations.
 - Four special sections have been published since the last Annual Business Meeting: ELLS-IAGLR 2018; Speciation in Ancient Lakes; Asian Carps; Toronto Area of Concern. Six more are in development: Lake Winnipeg; Beach and Dune Systems; Sea Lamprey International Symposium III; Lake Ontario 2020; Communities and Organizations; Bridging Knowledge System.
 - The Lakes Letter has been moved from the Publications Committee to the Communications and Outreach Committee, but continues to be distributed to all IAGLR members.
- 7. Nomination report (prepared by Paul Sibley, presented by Ed Verhamme)

- 8. Membership committee report (prepared by Jean Adams and presented by Ed Verhamme)
 - At the time of the meeting IAGLR had 421 members, with 304 from the USA, 112 from Canada, and 5 from other countries.
